This is a two component polyamine cured pure epoxy coating. It is a fast drying, superb mechanical strength, high solids, high build product. Specially designed as a premium coating for cargo holds where long term performance and long repair intervals are required. To be used as primer as a part of a complete system in atmospheric and immersed environments. Suitable for properly prepared carbon steel and shop primed steel substrates. It can be applied at sub zero surface temperatures.

Discoloration may be observed after deballasting. This will however not affect the protective properties.

Specially designed for long term performance in cargo holds and on hatch coamings. The quick curing of the coating gives the industry leading, shortest waiting time before taking first cargo. FDA compliant with grain certificate. Can be used for cargo ballast holds.

Walk-on-dry: Minimum time before the coating can tolerate normal foot traffic without permanent marks, imprints or other physical damage.

Dry to over coat, minimum: The shortest time allowed before the next coat can be applied.

Dried/cured for service: Minimum time before the coating can be permanently exposed to the intended environment/medium.
