## **Product description**

This is a two component polyamide cured vinyl epoxy based coating. Specially designed as a fast drying, flexible, tie coat between Jotun epoxy primers and antifouling systems. To be used as tie coat in immersed environments. It can be applied at sub zero surface temperatures.

#### **Typical use**

General:

Suitable as tie coat for a wide range of Jotun antifouling products.

Marine:

Specially designed for newbuilding construction where fast drying and over coating is needed.

Protective:

Suitable as tie coat in a complete system during newbuilding, exposed to a wide range of corrosive environments up to very high, and immersed. Recommended for offshore environments, including splash zones.

### Technical Data Sheet Safeguard Plus



Drying and curing times are determined under controlled temperatures and relative humidity below 85 %, and at average of the DFT range for the product.

Surface (touch) dry: The state of drying when slight pressure with a finger does not leave an imprint or reveal tackiness.

Walk-on-dry: Minimum time before the coating can tolerate normal foot traffic without permanent marks, imprints or other physical damage.

Dry to over coat, minimum: The shortest time allowed before the next coat can be applied.

Dried/cured for service: Minimum time before the coating can be permanently exposed to the intended environment/medium.
