Can be used as mid coat or finish coat in atmospheric environments. Suitable on approved primers on concrete substrates.

Application

Application methods

The product can be applied by

Spray: Use airless spray.

Roller: May be used for small areas.

Conditions during application :

The temperature of the substrate should be minimum 10 °C and at least 3 °C above the dew point of the air, measured in the vicinity of the substrate. Good ventilation is usually required in confined areas to ensure proper drying. The moisture content in the substrate should not exceed 4 % (by weight). The coating should not be exposed to oil, chemicals or mechanical stress until fully cured.

Product mixing ratio (by volume)

No part mixing of this product.

Use a slow speed drill and mixing paddle. Pour the full contents of the mixed material onto the floor immediately after mixing is completed.

The temperature of base and curing agent is recommended to be 18 °C or higher when the paint is mixed.

Dry to over coat, maximum, atmospheric: The longest time allowed before the next coat can be applied.

Dried/cured for service: Minimum time before the coating can be permanently exposed to the intended environment/medium.
